Terms and Conditions

1. **Term and Termination:** This contract shall be effective as of the date first above written and shall remain in effect through October 31, 2017. Either party may terminate this Contract upon giving thirty (30) days advance written notice to the other party prior to the effective date of termination. Upon termination, the County shall in a timely manner compensate Contractor for all amounts due for materials used and work completed as of the effective date of termination.

2. **Scope of Work and Cost of Service.** Contractor shall provide mowing and other services as described on the Scope of Work and Cost of Service attached as **Exhibit A**, which is hereby incorporated into this Contract as if fully set forth herein. The undersigned agrees to furnish all equipment and services necessary to complete this Contract to the full and entire satisfaction of Washington County, with the definite understanding that no money will be allowed for extra work except as specifically stated in this Contract.
