

The Washington County Electoral Board met at 9:00 a.m. on March 2, 2016 in the office of General Registrar to conduct the canvass of the March 1, 2016 Dual Presidential Primary. James Bebout, John Lamie and Constance Bundy were in attendance. Derek Lyall, Director of Elections, was also in attendance.

The first order of business was to reorganize the Board for the new year. The following elections were unanimously made:

James M. Bebout—Chair

John M. Lamie—Vice Chair

Constance T. Bundy--Secretary

The Board then went into closed session for consideration of provisional ballots. After coming out of closed session, the Board indicated that there were a total of 5 provisional ballots; three in the Democratic Primary and two in the Republican Primary. One Democratic ballot was from a voter who voted at the wrong precinct. One Democratic ballot and one Republican ballot were from voters not listed in the pollbook. None of those ballots were counted.

One Democratic ballot and one Republican ballot were from voters who did not provide a valid photo ID. Those voters have until Noon on March 4 to provide valid photo ID.

At this time, the Electoral Board proceeded with the canvass, and continued until 11:30 a.m. Minor questions arose about the Statement of Results at the following precincts: South Abingdon, Glade Spring, Valley Institute and Wallace. The Board directed the Director of Elections to speak with one of the Chief Officers of Elections at the above-referenced precincts to seek clarification about the Statement of Results. At this time, the Board recessed the meeting to 1:30 p.m. on Friday, March 4, 2016.

The meeting resumed at 1:30 p.m. on March 4, 2016. All members were in attendance along with the Director of Elections. The Director of Elections reviewed with the Board the Statement of Results from the South Abingdon, Glade Spring, Valley Institute and Wallace precincts following his conversations with the appropriate Chief Officers of Election. The Board then went into closed session for consideration of provisional ballots. After coming out of closed session, the board announced that no IDs had been provided by the deadline by the two voters who cast ID provisional ballots. With these outstanding matters resolved, the canvass concluded.

The Board certified the Official Results on the abstract of votes that are attached hereto and are incorporated in these minutes. Certified copies of the abstract were given to the Director of Elections to be forwarded to the State Board of Elections and the Circuit Court Clerk.

There being no further business, the meeting was adjourned at 2:15 p.m.
