

The Washington County Electoral Board met at 2:30 p.m. on May 4, 2016 in the office of General Registrar to conduct the canvass of the May 3, 2016 General Election. James Bebout, John Lamie and Constance Bundy were in attendance. Derek Lyall, Director of Elections, and Cindy Patterson, candidate for Abingdon Town Council, were also in attendance.

The Board reviewed and approved minutes from prior meetings.

Mr. Lyall advised that only one provisional ballot was cast—by a voter who did not have a valid photo ID. The board chose to defer action on this ballot for the moment.

The Electoral Board proceeded with the canvass, and continued until 3:15 p.m. when the canvass was completed. The only other pending matter was to give the provisional voter until 12:00 Noon on May 6 to provide a valid photo ID. At this time, the Board recessed the meeting to 12:30 p.m. on Friday, May 6, 2016.


