
The minutes for the prior meeting were approved.

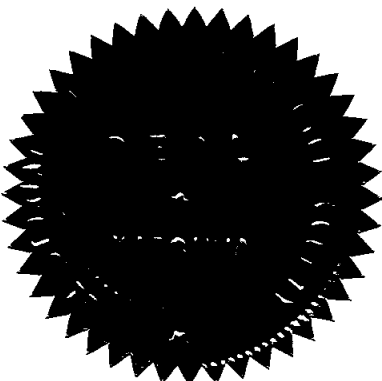
