ORDER AND WRIT OF SPECIAL ELECTION

This action came to be heard upon the Petition of the Town of Glade Spring, Virginia pursuant to Section 24.2-226 of the 1950 Code of Virginia, as amended, for the issuance of a writ for a special election to fill a vacancy upon the Town Council of the Town of Glade Spring, Virginia caused by the resignation of Mr. Jerry Taylor Coleman. In consideration whereof, the Court has determined as follows:

1. That the Town of Glade Spring is located within Washington County, Virginia, thereby conferring jurisdiction upon this Court;
2. That Mr. Jerry Taylor Coleman was elected on November 8, 2016 as a member of the Town Council of the Town of Glade Spring for a four year term ending December 31, 2020;
3. That Mr. Jerry Taylor Coleman took office on January 1, 2017;
4. That Mr. Jerry Taylor Coleman resigned said office on March 4, 2019; and
5. That the next general election for members of the Town Council of the Town of Glade Spring is scheduled for November 3, 2020.

Accordingly, it is ADJUDGED and ORDERED:

1. That a writ for a special election for the remaining unexpired portion of the term of office of Town Council member of the Town of Glade Spring, Virginia


vacated by the resignation of Mr. Jerry Taylor Coleman shall be and hereby is issued, said term of office to expire on December 31, 2020; and

2. Said special election shall be held on November 5, 2019.

The Clerk shall transmit a *teste* copy of this Order and Writ of Special Election to: Dr. John O'Bannon, Secretary, State Board of Elections, Washington Building, First Floor, 1100 Bank Street, Richmond, VA 23219; Mr. Derek Lyall, Washington County General Voter Registrar and Director of Elections, 1 Government Center Pl, Suite A, Abingdon VA, 24210; and counsel of record.

There remaining nothing further to be done in this action, the Clerk shall strike this case from the active docket of the Court and place its papers among the ended causes.
