

The Washington County Electoral Board met at 10:05 a.m. on June 12, 2019 in Conference Room 2 of the Government Center Building to conduct the canvass of the June 11, 2019 Republican Party Primary Election. James Bebout, John Lamie, and Constance Bundy were in attendance. Derek Lyall, Director of Elections, was also in attendance.

The board then went into closed session for consideration of provisional ballots. After coming out of closed session, the Board indicated that there was one provisional ballot. The board agreed that the provisional ballot would be counted.


At this time, the electoral board proceeded with the canvass. At the conclusion of the canvass, the board directed Mr. Lyall to print the final abstracts of votes for the election. After Mr. Lyall returned, the board signed the abstracts.


Next, the board unanimously voted to appoint Derek Lyall to a new four year term as Director of Elections and General Registrar. The new term will begin on July 1, 2019.


Next, Mr. Lyall asked the board to authorize him to appoint two full-time assistant registrars to a term of four years to coincide with his term. The board unanimously agreed to do so.

Finally, Mr. Lyall advised the board that the Virginia Department of Elections would like to conduct a pilot risk-limiting audit of the results of the June 11 Republican Party Primary in the 5<sup>th</sup> District later this summer. After some discussion, the board indicated that they had no objection to Washington County participating in this pilot.

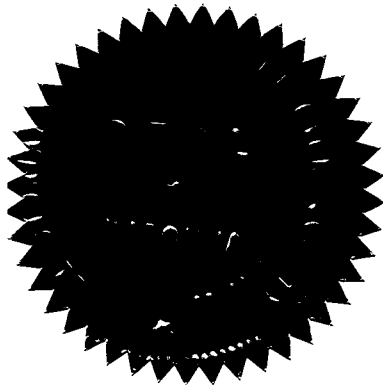

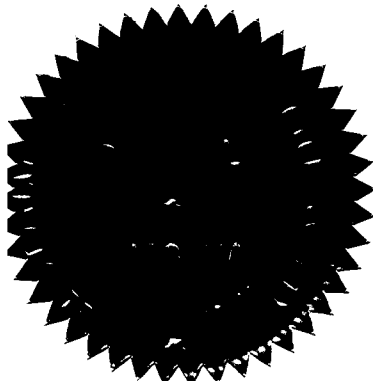
