2020 WASHINGTON COUNTY PARK TEMPORARY CAMPING RULES AND REGULATIONS FOR CAMPER AND TENT CAMPING

IF YOU CHOOSE TO VIOLATE THE RULES YOU RISK BEING REMOVED FROM THE PARK WITH NO REFUND OF ANY FEES PAID:

1. Camping has a maximum stay of two weeks and camper must be removed from the property after the fourteen days. Limit to a two week stay in a thirty-day period.
2. Practices NOT allowed in the Park and Tent Camping area:
 - a. Use of a generator is prohibited
 - b. Use of controlled substance or intent to distribute is prohibited
 - c. No open display of alcoholic beverages allowed in the Park.
 - d. Firearms, weapons and fireworks are prohibited
 - e. Loud noise of any type that may be a nuisance to others is prohibited
 - f. Vehicles that exceed State or County noise level are prohibited
 - g. Pets roaming free (pets must be on a leash at all times and picked up after)
 - h. Untagged vehicles are prohibited
 - i. Camping outside the designated tent camping area is prohibited
3. All motorized watercrafts must be launched from the boat launching facility ONLY
4. Setting up more tents than paid for will be charged double
5. Barbecue grills are to be cleaned before you leave your campsite
6. Renter is responsible for the conduct of family, invited guest and liable for any damage to property or equipment belonging to the park.
7. Small, contained, covered campfires are allowed. Open fires must be kept 50 feet from closest camper. No standing wood may be used.
8. Speed Limit in the Park is 5 MPH.
9. Quiet time is observed from 10:00 pm – 8:00 am
10. All State and County laws and regulations are to be abided by in the Park
11. All facilities at Washington County Park are used at your own risk.

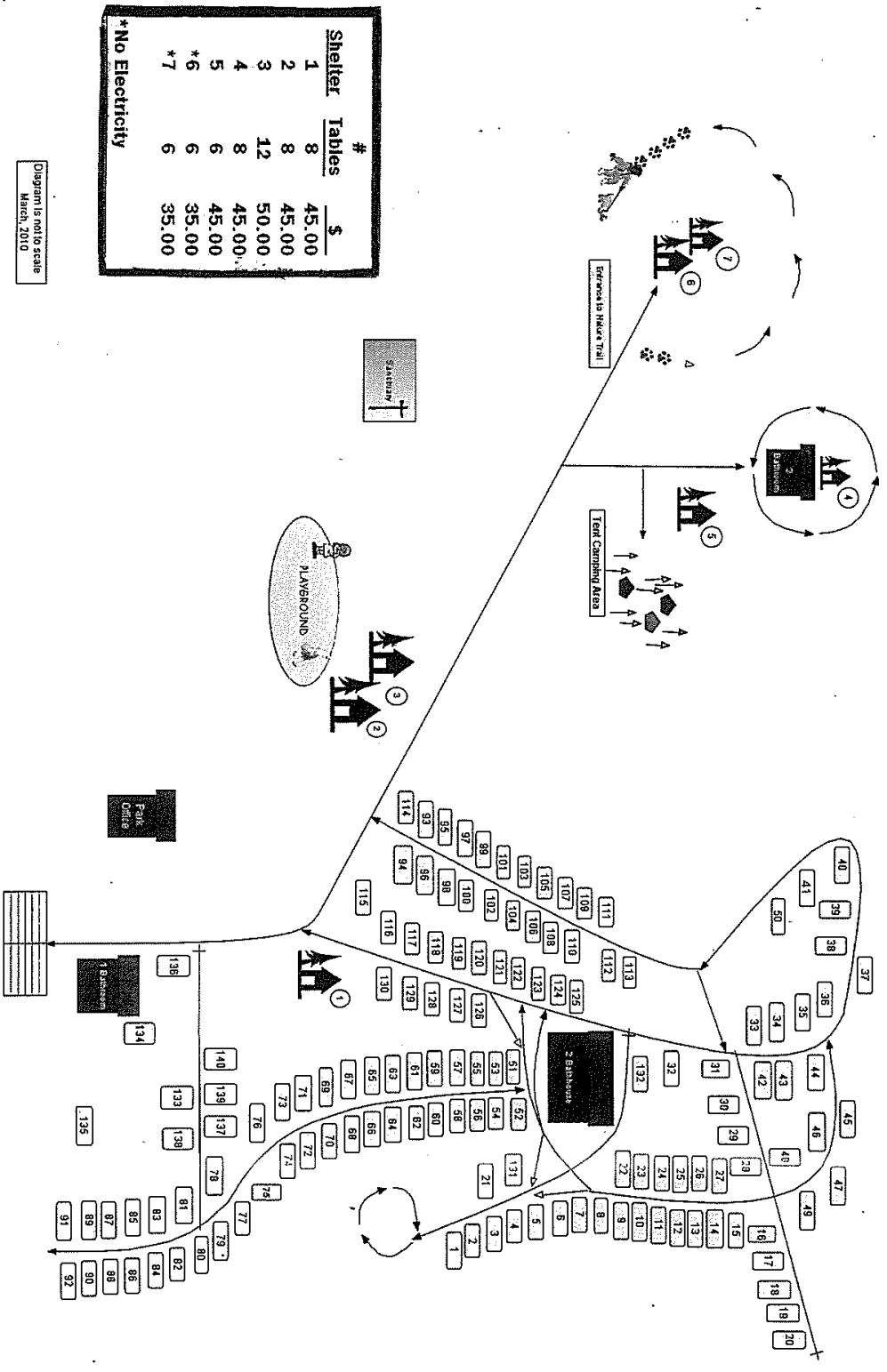
