Weekly Progress Report #3 8.14.22 – 8.20.22

Summary

Skanska was on site to observe and record work in progress. Hauling of debris continued as well as crane pad foundation work. Skanska checked in with the contractor on site to discuss the work planned for each day, reviewed submittals and RFIs, and prepared documentation for owner direct purchase orders.

Construction Progress

- Demolition of old sally port foundations continued.
- Continued work on crane foundation including undercut, pouring of flowable fill backfill, and installation of beam support.
- Continued hauling excess debris off site.
- Rebar for building foundations was delivered.
- Removed existing split system unit that served rooms P03 & P03B (see note 4 on drawing sheet M1.1).



Upcoming Activities

- Completion of crane pad foundation.
- Start of micro-pile installation.

Safety and Quality Assurance

- No safety issues were observed on site.
- Skanska is concerned about the possibility of the brick wall on the adjacent property cracking or collapsing during undercut for the building pad.

• Skanska requested an updated construction schedule from BurWil during the progress meeting on 8/10/2022 but schedule has not yet been received.
