



# Erosion & Sediment Control/Stormwater Management Plan Submittal Application

No person may engage in any land disturbing activity located in Washington County Virginia where 10,000 square feet or more of land disturbance is proposed until they have submitted to the County an Erosion & Sediment Control Plan and the plan has been reviewed and approved. A land disturbing activity is defined as any land changes that may result in soil erosion from water or wind and the movement of sediments into State waters or onto lands in the Commonwealth, including, but not limited to, clearing, grading, excavating, transporting and filling of land.

## MINIMUM SUBMITTAL CRITERIA FOR PLAN REVIEW:

- Land Disturbance < 10,000 sq. ft. but > 1 acre requires the following:**
- Erosion & Sediment Control Plan
    - o Plan should include both \_\_\_\_\_ narrative and \_\_\_\_\_ plan sheets.
  - Copy of VDOT Entrance Permit

- Land Disturbance < 1 acre requires the following:**
- Stormwater Management Pan (include ESC Plan)
    - o Plan should include both \_\_\_\_\_ narrative and \_\_\_\_\_ plan sheets.
  - Stormwater Pollution Prevention Plan
  - Drafted Stormwater Maintenance Agreement
  - Copy of VDOT Entrance Permit

## ADDITIONAL SUBMITTAL CRITERIA FOR PLAN REVIEW:

- Copy of DEQ's Permit/Determination Letter if work is planned that might impact any wetland area.
- Copy of any Land Use Agreement(s) if other properties are being used as a part of the above-mentioned project.
- Copy of Army Corp of Engineers Permit/Determination Letter if work is planned within the annual highwater level of any stream and/or river.
