- **Virginia Department of Health Septic System Approval where no public sewer service is available or proof of connection to public sanitary sewer service.**
 - Approval from the Department of Health may be in the form of a Septic System Construction Permit or a Safe, Adequate, and Proper Determination (if using existing septic system).

- **Virginia Department of Health Well System Approval where no public water service is available or proof of public water connection.**

- **Proof of Ownership**

 - Site plan will need to include proposed location of the structure along with distances to the adjoining property lines.
