Weekly Progress Report #36

Summary

Construction progressed well again this week as steel trim out and roofing installation continues. Concrete slab-on-deck was poured on third and fourth floor areas on the west side of the building. Exterior and interior wall framing continue in addition to blocking for interior walls and windows. MEP rough-in continues throughout the building and rooftop curbs are being set. The project remains on schedule and within budget.

This week Skanska observed and documented work in progress, reviewed open RFIs and the status of submittals for upcoming work, reviewed/approved invoices, and confirmed deliveries for Owner-purchased materials. Opportunities for additional savings through the Owner Direct Purchase process continue to be explored.

- Roof blocking on 1 line, parapet blocking.
- Interior wall and window blocking.
- Terrazzo floor pattern layout third floor lobby.
- Door frame bracing install.
- Fourth floor electrical wall rough-in.
- Fourth floor above ceiling rough-in.
- Temporary lighting in multiple locations third and fourth floors.
- Brick and block XA line at Plumb Alley.
- Third floor exterior wall framing on X12 line.
- Fourth floor exterior framing X12 line.
- Interior wall framing third floor courtroom area.
- Mechanical roof curb work for roof top units.
- Poured slab-on-deck for third and fourth floors from XA to XB.
- Cast iron piping for roof leaders third floor.
- Sequence 9 roof drain install.
- Installing roof membrane sequence 10-13 areas.
- Steel trim out for sequence 11 roof.
- Steel trim out for sequence 9 roof at old prisoner elevator extension.

Safety and Quality Assurance

- No safety incidents reported to date.
- Skanska continues to observe and document work in progress.
- FSE continues to observe work and inspect structural steel connections.


