2. **Attach copies of proof**, i.e. oil change receipts, state inspection slips, repair bills, detailed mileage logs. **Please do not send the dated originals**. If you prefer, you may bring the vehicles to our office (1 Government Center Place, Suite C) for a visual verification of the vehicle's mileage.
3. Return the application and proof to the address listed above by **October 1**.
