

To Vendors for Invitation for Bids for Mowing Services for Washington County, Virginia:

The following questions were received from vendors. In order to keep everyone informed, here are the questions and answers:

1. If possible, could you provide us with pictures for the locations and total number of acres that needs to be mowed per location. **On page 6, item G, Inspection of Job Site, in the Invitation for Bid, it is the responsibility of the bidder to inspect the job site and become aware of the conditions under which the work must be accomplished. No pictures of the location and number of acres will be provided due to this requirement.**
2. I also wanted to know is the address for the library, 2015 Oak Hill Street; Abingdon, correct? When I try to type it in it doesn't show up however 205 Oak Hill showed up instead. **The correct address is 205 Oak Hill St NE, Abingdon, Virginia 24210.**
3. Are you able to provide the last bidding prices? **See attached bid tabulation from the last procurement.**
4. On the solicitation it lists Abingdon Library. Would this be the Washington County Library? **Yes, this is Washington County Public Library.** Are you able to provide additional information regarding what exactly is expected to be mowed at this location? **Around the entire building starting at Valley Street, also include around the rear of the property to include around the parking area all the way north to the white pine trees.**
5. The Green Cove Community Center, is it just the building or is the station included in this as well? **It will be everything between the paved road up to the edge of the Creeper Trail.**
6. For the Glade Highland Industrial Park are you able to provide the locations of Lots 1, 2 and 3? **As you turn into the Industrial Park off of Lee Hwy, it will include all the property on your right up to the Food City building.**
