AMENDED WRIT OF ELECTION

The School Board of Washington County, Virginia (School Board), petitioned this Court to issue a writ of election to fill a vacancy in the office of School Board member for the Monroe District of Washington County, pursuant to the provisions of Section 24.2-226 of the Code of Virginia.

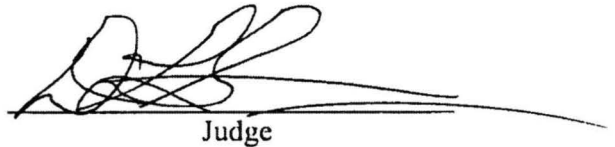
Upon consideration of the Petition, and the representations made therein by the School Board, the Court finds that the office of School Board member for the Monroe District became vacant effective on June 9, 2026, and that the regular term of the office will expire on December 31, 2027, in accordance with law.

NOW THEREFORE, pursuant to the provisions of Virginia Code Section 24.2-226, this Court, upon consideration of the Petition and the representations of Washington County School Board, does hereby ADJUDGE, ORDER, and DECREE the issuance of this writ of election, directing the Secretary of the Electoral Board of Washington County and all other appropriate officials, as necessary, to proceed to cause public notice to be given of and do all other necessary and proper things for the special election, to be held on the date of the next general election in November 2026, at the regular polling places of the Monroe District in Washington County, Virginia, to elect a School Board member for the Monroe District in Washington County, Virginia, to hold such office for the remaining portion of the regular term for which the vacancy is being filled, namely, until December 31, 2027.

The Clerk is directed forthwith to post at the courthouse and also to forward an attested copy of this writ of election to the Secretary of the Electoral Board of Washington County, the Secretary of the State Board of Elections, and the Clerk of the Washington County School Board.

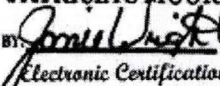
This Amended Writ of Election supersedes the previous Writ entered by the Court on June 12, 2026.

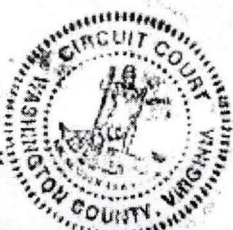
